European Account Preservation Order



With financial support from the Justice

The European Account Preservation Order (EAPO) lets a court in one EU country freeze funds in the bank account of a debtor in another EU country. The procedure may be used in cross-border cases only, whereby the court carrying out the procedure or the country of domicile of the creditor must be in a different Member State than European Account Preservation Order the one in which the debtor's account is maintained. The

procedure for getting an EAPO is set out in Regulation (EU) No 655/2014. It's an alternative to existing legal procedures in each EU country.

The webinar aims to provide an overview of the topic through the opinions of relevant experts. A Q&A session will follow at the end of all the presentations.
